Effective July 1st, 2024, all service lines of the Center for Research Informatics are now operating within a federal recharge center. This transition was implemented to sustain services supported or subsidized by federal awards and ensure compliance with federal regulations outlined in [University Policy 1005](#). CRI services are partially subsidized by generous support from the BSD Dean's office.

We are dedicated to meeting your specific requirements and will work closely with you to align timelines and costs with your project goals. See our current approved hourly rates below, these rates will not affect the ability to direct charge to grants. Please note that recharge rates are subject to annual review and may change each fiscal year.

Service	Service Description
Bioinformatics Analysis	Bioinformatics analysis of high-throughput biological data, including proteomics, using our well-defined analysis pipelines including all consultations, meetings, grant preparation, and manuscript development related to these projects. Should a Biocore employee be included on a grant for these services, initial consultation, grant and manuscript writing fees will be bundled with effort on the grant. 1 hour of consultation time is provided at no charge.
Application Development	Application Development includes creating a computer program or a set of programs to perform the different tasks including all consultations, meetings, grant preparation, and manuscript development related to these projects. Should a Biocore employee be included on a grant that supports these services, initial consultation, grant and manuscript writing fees will be bundled with effort on the grant. 1 hour of consultation time is provided at no charge.

CRI Service Descriptions, effective July 1, 2026:

Service	Service Description
Clinical Research Informatics	Clinical Research Informatics services include all activities related to the acquisition, positioning, and delivery of clinical or multi-omic data including ETL processes, datamart maintenance, de-identification services, clinical data science, and natural language processing services. Should a CRI employee be included on a grant that supports these services, initial consultation, grant and manuscript writing will be bundled with effort on the grant. This also includes consultation services and activities related to CRDW activities such as grant or IRB writing assistance, cost analysis, letters of support, documenting the availability of tools, data, and expertise for any CRDW project, developing or amending a service level agreement, manuscript writing, including assistance writing the components and methodology for CRDW are also included. 1 hour of consultation or project management time is provided at no charge.
Application Development	Application Development includes creating a computer program or a set of programs to perform the different tasks. Should a CRI employee be included on a grant that supports these services, initial consultation, grant and manuscript writing will be bundled with effort on the grant. This also includes consultation services and activities related to Application Development activities such as grant or IRB writing assistance, cost analysis, letters of support, documenting the availability of tools, data, and expertise for any CRDW project, developing or amending a service level agreement, manuscript writing, including assistance writing the components and methodology for Application Development are also included. 1 hour of consultation or project management time is provided at no charge.
Research Storage	Secure research storage services are all activities related to providing HIPAA secure storage in the CRI's data center. 4 TB of free storage are provided to each PI/year.
Winstats/Premium HPC Membership	Premium HPC membership is access to systems that have licensed commercial software.

REDCap	REDCap services are electronic data capture services through our REDCap application. Services are provided on a fee for service basis derived by the consumption of units. Services are provided to academic medical center trainees (residents, fellows, medical students) at no charge
Bring Your Own Hardware (BYOH)	Bring Your Own Hardware Services are rack units provided to clients on a fee for service basis which implementation, integrations, and ongoing maintenance. Upfront consultation services for this service are required but free. Ongoing consultation after moving to production are on a fee for service basis.
General Data Transfer	Transfer of data into or out of the CRI environment. Transfers using Globus is free.
NIST Data Transfer	This service is the required chaperoned transfer of NIST data into and out of the CRI environment using Globus or other means.
